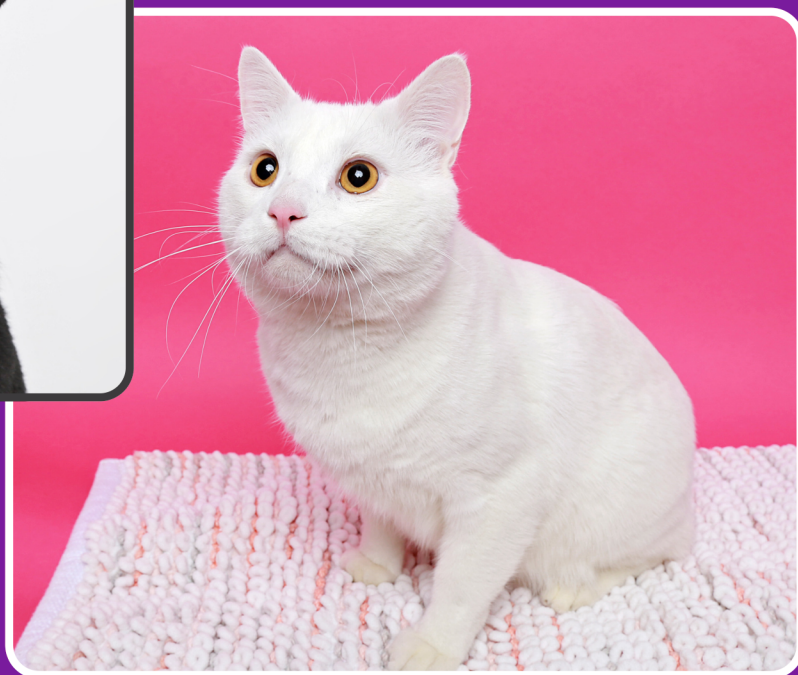
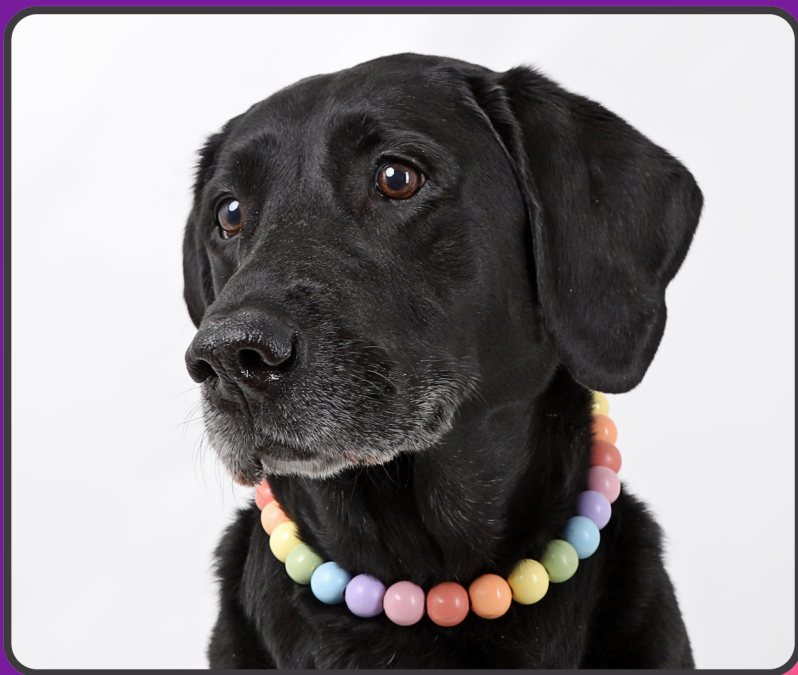


Pet Legacy Profile

Before submitting this form please read our Pet Legacy policies and guidelines. If you have questions about any of these policies, please contact our staff before submitting your form.

- You may choose to include the Humane Society of Utah (HSU) in your will or other estate plans in conjunction with the Pet Legacy Program. We appreciate this incredibly kind gesture and we recognize the importance of such a contribution. We will use these funds to help provide for your animal(s) while they are in our care, and any remaining funds to support our other animals and programs. Please understand that the Humane Society of Utah cannot facilitate the transfer of funds to the new adopter of your pet. If you wish to have additional funds set aside for the adopter of your animal, we can help provide names and contact information where appropriate. However, the transfer of those funds must be handled directly by your executor or estate administrator.
- The Humane Society of Utah cannot provide animal transport beyond a 30-mile radius from our Murray facility located at 4242 S, 300 W, Murray, UT 84107. If your estate representative needs assistance with animal transport, they must contact the Humane Society of Utah. The date and time of transport must be mutually agreed upon by the estate representative and HSU. Other limitations may apply based on the needs of the animal and/or the organization.
- The Humane Society of Utah evaluates each animal upon arrival at our facility. If an animal is determined to be behaviorally or medically unhealthy, untreatable, or unmanageable, the animal may not be a realistic candidate for adoption. Please understand that euthanasia is a possibility in some cases. By submitting this form, you are giving the Humane Society of Utah consent to evaluate your animal(s) upon intake and determine the appropriate outcome based on each animal's health and behavior at the time.
- Please understand that any animal surrendered to the Humane Society of Utah is legally released to our organization. All ownership rights and control are relinquished to the Humane Society of Utah upon intake. The Humane Society of Utah reserves the right to make any and all decisions regarding the welfare and outcome of the animal(s) following intake.
